I hereby waive written notice that employment information is being provided by any person or organization.
- 3. Employment at Will. If I am hired, in consideration of my employment, I agree to abide by the rules and policies of Manistee County Road Commission, including any change made from time to time, and agree that, subject to the provisions of any written agreement to the contrary, my employment and compensation can be terminated with or without cause, and with or without notice, at any time, at the option of either the Manistee County Road Commission or myself.
